Health Insurance Premiums Paid for S-Corporation Shareholders

To comply with the Internal Revenue Service regulations regarding health insurance provided to an employee who owns a 2% or greater interest in an S-Corporation (a “2% shareholder-employee”), the health insurance premiums for the 2% shareholder-employee must be reported on the shareholder’s **2021 form W-2**. In addition, the health insurance policy should be issued under the Corporation’s name.

Under these regulations, the S-Corporation will be entitled to deduct the insurance premiums, and the 2% shareholder-employee will be entitled to deduct, as an adjustment to gross income, the amount reported on the W-2. The amount of the health insurance premiums included in the 2% shareholder-employee’s W-2 will be subject to income tax, but **will not** be subject to Social Security, Medicare or Federal and State Unemployment taxes.

Would you please provide us with the health insurance premiums paid on behalf of 2% shareholder-employees during 2021. We will include this amount in the Corporation’s 4th quarter and annual payroll reports and on the **2021 W-2’s**.
